The current owners were recently impacted by the September and October 2024 hurricanes after many years of taking care of this special home. The home is now being sold ASIS with the possibility to be restored by the future homeowners and filled with new memories or the opportunity to build a new home. Pictures of the home were taken in March of 2024 and show the potential of this 2,600 sqft home. Renovate and add your own personal touch or build a new home on a large lot just over 10,000 sqft, similar to the lot size of the home directly across the canal, but with more expansive views of the sparkling bay and the Sunshine Skyway bridge. Updates in the last two years include Refrigerator 2024, Microwave 2024, Washer 2023, Dryer 2023, and Renewal by Andersen Sliders 2024. Noticeable differences from the pictures pre hurricane to post hurricane damage include and are not limited to the drywall having been cut out and cabinets ventilated at the base. The dishwasher no longer functions, the split unit in the primary bedroom no longer functions, and the wine refrigerator was removed and will not be replaced. The wood flooring in various areas was also affected.



Exterior differences include broken sprinkler heads in various locations, landscaping flora has changed, the fence and backyard pavers have shifted, the hot tub no longer functions, and the dock was damaged and will need to be assessed and remediated by the future owner. Hurricane shutters around the house are in good condition with the exception of some fabric shutters on the pool patio. The owner is unsure if the boat lift works and will be looking into this in the coming weeks. Post hurricane, the owner put in a new Pool Pump 2024 and will be installing a new \$11,000 A/C Condenser before the end of November 2024. This home is seeking owners ready to renovate or build a custom home to make new lasting memories. Come take a look and see the potential! The views of the bay will not disappoint!
